

**CITY OF ALBION  
ORDINANCE #2015-05**

**AN ORDINANCE TO AMEND MUNICIPAL CIVIL INFRACTIONS ORDINANCE BY  
AMENDING SECTION 1-26(g)(3)**

Purpose and Finding:

With the adoption of Ordinance #2015-04, schedule of penalties is necessary for the enforcement of the non-discrimination ordinance. This ordinance would add civil penalties to Section 1-26(3)(g) and provide the penalties for first and subsequent offenses.

THE CITY OF ALBION ORDAINS:

Section 1-26(g)(3):

- b. For failure of any contractor or other person to pull a permit before commencing a project within the City of Albion which is required by the Building Code, the Electrical Code, the Mechanical Code or the Plumbing Code shall be guilty of a civil infraction, except in an emergency that occurs on a weekend or when city hall is closed. The fines for the violations listed in this subsection shall be as follows:

First Offense .....150

- Second Offense .....300
- Third and any Repeated Offense .....500




